

AIRSOFT ORGANIZATION OF SOUTH CAROLINA EVENT WAIVER

In consideration of Airsoft Organization of South Carolina (herein referred to as the AOSC) furnishing services and/or equipment to enable me to participate in airsoft games, I agree as follows: I fully understand and acknowledge that: **(a)** serious health risks and dangers exist in my use of airsoft equipment and my participation in airsoft activities: **(b)** my participation in such activities and/or use of such equipment may result in my injury or illness including but not limited to bodily injury, disease, strains, sprains, fractures, broken bones, partial and/or total paralysis, eye injury, blindness, heat stroke, dehydration, heart attack, injury which results in amputation, death or other ailments that could cause serious disability: **(c)** these risks and dangers may be caused by the negligence of the owners, officers, representatives, land owners or agents of the AOSC: the negligence of the participants, the negligence of others, accidents, breaches of contract, the forces of nature and other causes: **(d)** by my participation in these activities and/or use of equipment, I hereby assume all risks and dangers and all responsibility for any losses and/or damages, be they property, monetary, emotional or physical distress, or loss of mental or physical functions, whether caused in whole or in part by negligence or other conduct of the principals, land owners, agents, third parties, or any person connected with the AOSC or this event, or by any other person. I on behalf of myself, my personal representatives and my heirs, hereby voluntarily agree to release, waive, discharge, hold harmless, defend and indemnify the AOSC, its officers, representatives, agents, land owners, and third parties from any and all claims, actions or losses for bodily damage, wrongful death, loss of services, loss of consortium, loss of wages present or future or otherwise which may arise of my use of airsoft equipment or my participation in airsoft activities. I specifically understand that I am releasing, discharging and waving any claims or actions that may have presently or in the future for the negligent acts or other conduct by the AOSC, its agents, representatives, land owners, or third parties. The AOSC reserves the right to capture, reproduce all photographs, video or any other form of imagery for promotional purposes either for print or for web advertising. If any participant chooses to have their images excluded from the AOSC advertising you must inform us in writing. I have read and understand the above; I agree to release the AOSC and the field owner of the property being used for this airsoft event from all liability relating to this airsoft event. By signing this total release of liability, I am also affirming that I am of sound mind and have no reason to absolve myself of the potential consequences of signing this document. By signing below, I also declare that I am either an adult over the age of eighteen years, or I am signing as the legally recognized parent or guardian of a minor who will be participating with my full and complete knowledge and consent.
